Sub.- Recognition/Approval of Fakhruddin Ali Ahmed Medical College, Barpeta, Assam for the award of MBBS degree (100 seats) granted by Srimanta Sankaradeva University of Health Sciences, Assam u/s 11(2) of the IMC Act, 1956.

Sir,

I am directed to inform you that the assessments to assess the standard of examination held by Srimanta Sankaradeva University of Health Sciences, Assam and to assess the physical and the other teaching facilities available for Recognition/Approval of Fakhruddin Ali Ahmed Medical College, Barpeta, Assam for the award of MBBS degree (100 seats) granted by Srimanta Sankaradeva University of Health Sciences, Assam u/s 11(2) of the IMC Act, 1956 were carried out by the Council assessors on 17th December, 2016 and 13th & 14th Feb., 2017. The assessment reports (17th December, 2016 and 13th & 14th Feb., 2017) were considered by the Executive Committee and subsequently by the General Body of this Council at its meeting held on 29/03/2017. The Council approved the following recommendations of the Executive Committee:-

The Executive Committee of the Council considered the assessment reports (13th & 14th February, 2017 and 17th December, 2016) and decided to recommend to the Central Government for recognition/approval of Fakhruddin Ali Ahmed Medical College, Barpeta, Assam for the award of MBBS degree (100 seats) granted by Srimanta Sankaradeva University of Health Sciences, Assam u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections B(3)(2), B(3)(3) & B(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

B (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute..."

In view of above, you are, therefore, requested to issue necessary notification at the earliest recognizing Fakhruddin Ali Ahmed Medical College, Barpeta, Assam for the award of MBBS degree when granted on or after December, 2016 by Srimanta Sankaradeva University of Health Sciences, Assam.

A copy of the assessment report is enclosed herewith.
