Sir/Madam,

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition of MS(Obstetrics & Gynaecology) qualification for 06 seats in respect of students being trained at Fakhruddin Ali Ahmed Medical College & Hospital, Barpeta, Assam under Srimanta Sankaradeva University of Health Sciences, Guwahati, Assam**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

4. You are directed to take corrective steps to rectify the deficiencies; and inform the Postgraduate Medical Education Board of NMC within six months from the date of issuance of this letter.
